## P.S. 276 Unveils Wall of Heroes

On Friday, May 17th, the staff of P.S. 276 Louis Marshall School, located at 1070 East 83rd Street, held a ribbon-cutting ceremony to unveil a "Wall of Heroes" in the school's auditorium. The walls were plastered with dozens of pictures honoring decades of leaders from every walk of life, from everywhere in the world.

There were images of world leaders such as Presidents Theodore Roosevelt, John F. Kennedy and Barack Obama; Civil Rights and political activists, Malcolm X, Rev. Dr. Martin Luther King Jr. and Nelson Mandela; sports figures, including tennis great Serena Williams, NBA player Kobe Bryant and Gold Medalist, gymnast, Gabby Douglas.

The Wall of Heroes also depicted educators, including District 18 School Superintendent Celeste Terry and P.S. 276 Principal Jennifer Troman and staff. It also spotlighted elected officials such as Minority House Leader, Congressman Hakeem Jeffries; State Senator Roxanne Persaud; Assemblywomen Jaime Williams and Monique Chandler-Waterman; and Councilwoman Mercedes Narcisse.

Troman said, "The mural is titled 'Wall of Heroes' and it honors decades of leadership. As a principal, it is my responsibility to ensure that students are on the college and career track from

the second they walk through our doors. At P.S. 276, we are creating opportunities for students to explore what their interests are, tap into their talents and find out who they want to be. We are teaching them about what it means to be a leader and how to aim high."

"I am honored to be included as one of the illustrious leaders featured in the 'Wall of Heroes' project," Persaud told the *Canarsie Courier*. "This educational mural gives our students a view of inspiring images of leadership every day so they may see what is possible as they continue to create our future."

**East New York****Barricaded Suspect Shoots Man, Evades Cops**

Detectives are investigating the circumstances that led to a shooting at 13 Malta Street last week.

Officers from the 75th Precinct arrived at the home, off of New Lots Avenue, around 4:20 p.m. on Thursday, May 16th, where they found a 20-year-old man suffering from gunshot wounds to the pelvis and right wrist.

Members of the Emergency Service Unit attempted to talk to the suspect through the front of the home and engaged him in conversation for two hours. According to an NYPD spokesperson, upon forcing entry into the home, the suspect had fled the scene.

A large number of cops canvassing the area had one

neighbor saying, "I've never seen so many cops on the block; I have lived here 22 years."

The victim was taken to Brookdale Hospital in stable condition.

## Bergen Beach Civic Installation Ceremony Highlights Celebrations and New Leadership

On Tuesday, May 14th, the Bergen Beach Civic Association (BBCA) held its official Installation Ceremony at the Hudson River Yacht Club, 2101 Bergen Avenue. The event welcomed new President Michael Trotta and board members, while also thanking outgoing President Sal Calise. The evening featured lighthearted banter, corny poems and unique ceremonial activities led by Community Board 18 (CB18) District Manager Sue Ann Partnow, who concluded with the creation of a rotini pasta salad, described by Calise as "Broadway show worthy." Students from local schools were also honored for their academic achievements.

In March, it was reported that Sal Calise was passing the torch to Michael Trotta (see "*Changing of the Guard: Bergen Beach Civic Welcomes New President as Sal Calise Bids Farewell*," *Canarsie Courier*, March 28, 2024). At the installation meeting, Calise received a plaque of appreciation for his "leadership, commitment and dedication to our community." The plaque reflected the board's sentiment that he set a high standard for the BBBCA.

Following the Pledge of Allegiance, the evening continued with community updates and appearances. Captain Ronald Perez, the newly appointed commanding officer of the 63rd Precinct, was introduced to the community. A 22-year NYPD veteran, Perez praised the 63rd Precinct officers, calling them "the best cops I've ever worked with." He announced the appointment of Detective Navarro as the Crime Prevention Officer and warned the community about a rise in vehicle thefts.

Students Sofia Barna from P.S. 312, Gianna Piccirillo from St. Bernard Catholic Academy and Victoria Kinch from Roy H. Mann I.S. 78 received awards for general excellence in academics and community service.

Ron Canterino, co-chair of the Coalition for Better Communities, spoke about the upcoming caravan and rally on June 23rd at 10 a.m. The event aims to address issues such as the migrant crisis, misuse of taxpayer dollars, public safety, education, healthcare and support for veterans. This rally follows the successful Kings Plaza Rally as reported in the April 18, 2024 issue of the *Canarsie Courier*.

Partnow's ceremony continued with the intriguing invocation of inaugural duties, discharging Calise and previous board members from their post, detailing Bergen Beach's history from its early days once called Bergen Island as an entertainment mecca with an amusement park and casinos, to its development into the tree-lined suburban neighborhood it is today. The installation culminated in the symbolic making of the pasta salad, with each ingredient representing an incoming board member and Trotta as the "Big Cheese," with his first official act, to top it off with shredded cheese. The edible creation was served up at CB18's meeting the following day.

# Flatlands Civic Recaps Scholastic News and Community Updates

For residents in the Flatlands area who haven't been able to attend local meetings, Joan Gilbert, president of the Flatlands Civic Club, Inc. (FCC), doled out plenty of resourceful information at her Zoom meeting on Thursday, May 16th.

First on the roster of pertinent advisories was an announcement that construction of the B82 Select Bus route along Flatlands Avenue was supposed to take place at the beginning of May.

Gilbert noted, "We don't have a specific update when this is going to start, but the e-mail we have is dated May 7th...The person in charge of the project said they received notice from the contractor that they'll begin cutting off Flatlands Avenue sometime this month. Community Board 18 District Manager Sue Ann Partnow mentioned at their recent meeting possible road

work north of Flatlands – just west of Ralph Avenue, so please keep an eye out on road closures."

Gilbert said the project will possibly include tree pruning and other construction that might require vehicles being towed away from the work site. The FCC president claimed the advisory stated that work would start at the "beginning of May." However, as of the FCC meeting, much of the preliminary road work had not yet begun.

Another important advisory Gilbert recapped was a "Know Your Rights: Community Driveways Edition" planned for 6 p.m. on Tuesday, June 4th, hosted at Councilwoman Mercedes Narcisse's District Office, at 5827 Flatlands Avenue. "There's going to be an attorney doing a 'Q & A' session at their office who's an expert on property rights. It should be very interesting because we all know how challenging it can be to

understand the legal rights of dealing with people who park in our driveways."

Assemblywoman Jaime Williams was in attendance and shared her dismay about scheduled plans to meet with developers that want to build a residential monstrosity at 5602 Flatlands Avenue as part of the "City of Yes" initiative.

"The developer was supposed to meet with the community near the site on May 10th. They canceled without proposing a new date," Williams said. "But the vote on City of Yes proposals is quickly approaching in June. We have to come out and voice our concerns at all of these meetings."

"Our community can change forever! We have to think – what will our city look like in five to 10 years from now. Keep spreading the word to your neighbors to come out because we can't do it alone. Some people don't want to be on their e-mails and they may not want to do the footwork to carry out the fight – but please pay attention to the bills that are coming up in the legislature and please don't have that mind frame of 'Oh, it's going to happen anyway.' We have to believe that our voices and actions will make a difference," Williams passionately said.

Speaking of making a difference, Gilbert gave an update on the Sam Palmer Memorial Scholarship Fund. The honorable program awards youngsters from local schools who were, in the 2023-2024 school year, "most improved overall" and those who embody community engagement – values upheld for many decades by Palmer, the late and highly respected FCC president.

"I want to thank you all of who have donated to the scholarship fund and Sam's legacy...So far we have about \$600, so we're looking to give scholarships to two kids – and the categories are civic engagement and education," Gilbert said.

Gilbert has met with one of the Parent Association representatives from a local school to vet students for the scholarship award. She will follow up with her connections before the last day of school to make the heartfelt grant possible.

## Building Climate Strong Communities

Members of the NYC Mayor's Office of Climate and Environmental Justice recently toured sections of Canarsie to identify areas suitable for possible federal and state grants for climate risk and sustainability projects.

Around 12 representatives from Mayor Eric Adams' office gathered to meet with local leaders, Maria Garrett, President of the Fresh Creek Civic Association; and Harold Jones, Executive Director of Canarsie Community Development Inc. (CCDI), on Friday, May 3rd. Both community activists participate in Climate Strong Communities, a virtual meetup of some of the city's leaders.

According to the city's webpage for Climate Strong Communities, the group will "invest in communities not addressed by limited Hurricane Sandy recovery funding, maximize federal and state infrastructure and climate funding opportunities, and develop a community-centered equitable planning process by proactively engaging with stakeholders."

Canarsie, as well as Brownsville,

Soundview (Bronx), Corona (Queens) and Port Richmond (Staten Island), were the areas selected as first-year participants in the Climate Strong Communities program. Public workshops were held throughout the year, and Jones and Garrett represented Canarsie at each event.

During the tour of Canarsie, the group visited Fresh Creek, Rockaway Parkway, the Canarsie Community Garden on Schenck Street, the Sebago Canoe Club and Canarsie Park. The Mayor's Climate Office submitted a request to FEMA, BRIC AND FMA for a feasibility study regarding extreme rain and heat adapta-



tion measures for parts of Canarsie and the Flatlands/Fairfield Industrial District. The *Canarsie Courier* was informed that FEMA will make its own decision on the applications sometime in August. As for a climate change grant or any other state funding linked to the tour, time will tell if Canarsie will be one of the communities selected for any possible future projects.

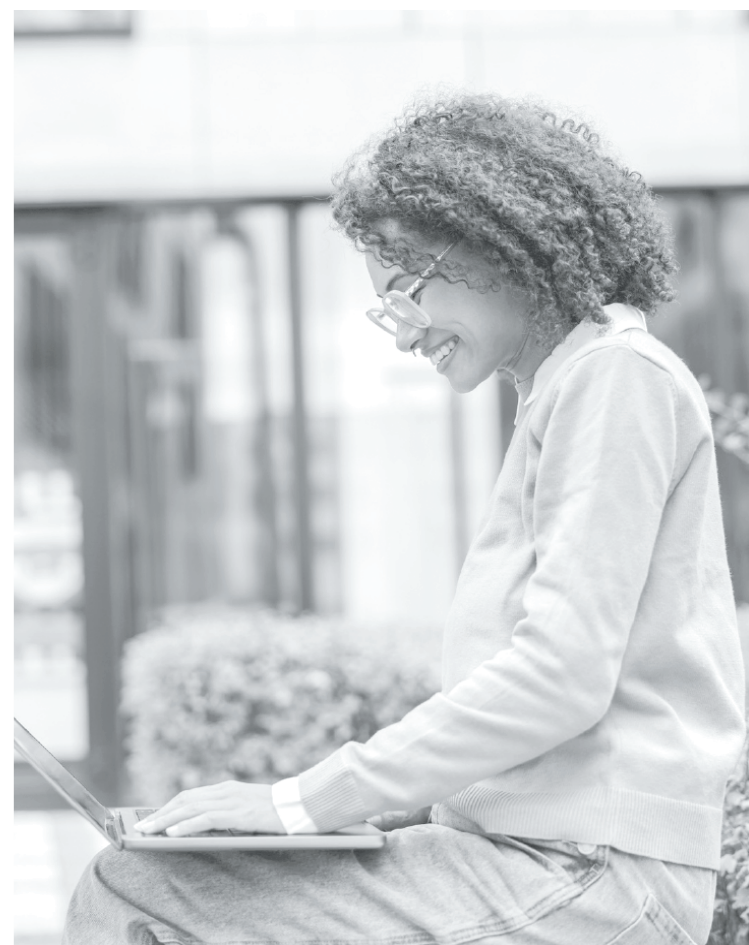

## From Kindergarten to College — How Public Education Can Play a Role in Strengthening Local Journalism

You'd have to be living under a rock if you haven't heard that local newspapers are dying at an alarming pace, especially within the last two decades — but what can we do about it?

Calls for help from the journalism landscape at the college level and within the profession, as well as advocacy for new journalism curriculums to promote lacking school newspapers at the high school level, and legislation to help prevent the collapse of the industry through the Local Journalism Sustainability Act, have all been circulating among the ruins, but a recent visit with public school students has sold me on the idea that we must start much earlier and when children are at the elementary school level.

On May 2nd, the *Canarsie Courier* paid a visit to over 40 newspaper club students across multiple grades taught by Language Arts teacher Genevieve Berretta at P.S. 119,

The Amersfort School and Magnet School of Global and Ethical Studies in Flatlands, located at 3829 Avenue K.

"News reporting opens a doorway — it opens eyes, hearts and minds," Berretta said. "We need to open all of these pathways for children and it should begin at the elementary level."

Berretta has been working at the school and helping to produce their school newsletter for about 15 years, creating a printed historical archive that now also appears online on their blog, *P.S. 119 School News*.

The students were inspired by *Canarsie Courier* articles written about events held at their school and wanted to learn more about journalism, so I, along with my editor, Linda Steinmuller, were invited by their teachers and principal to their first press conference to speak about our profession.

Their events caught my attention because of positive and uplifting themes at their annual Peace Parade and in an innovative music program, produced with established musicians on YouTube, promoting diversity. The inside of the school reflected the same theme.

Vibrant colors adorned the hallways, which were filled with beautifully decorated bulletin boards further promoting the positive values the school is known for. Principal Barbara Snow, Assistant Principal Sharod Clarke, Berretta and teachers have worked together for many years ensuring continuity of this work. They and their students gave us a warm welcome and were well prepared for our visit with questions in hand.

A lot of what we discussed involved the role of passion for journalism to inform our communities as a force for good. It's the reason why we as journalists and educators at P.S. 119 have been persevering to keep journalism alive in such a challenging environment. As an educator, Berretta has used the basics of journalism in her newsletter as a tool to teach her students the value of writing, promote communication skills and self-expression, and spark creative thinking.

Her students also serve as active change agents for their communities by writing persuasive letters to the schools that they plan to attend, requesting them to start a school newspaper and emphasizing the value of print as well as digital news. "I need the children to turn the pages and you can't get that feel with an online publication," Berretta said.

Berretta, who is now retired, returns one day a week to work with students on the newsletter. It's printed up to three times a year with financial support from the Parents Association and delivered to every student from Pre-K through 5th grade on glossy, colored and high quality paper. Berretta said that she wants to breathe new life into the 5W's (Who, What, Where, When and Why) with fair and balanced reporting.

"Getting children to write generally is challenging but when we make it purposeful, real and concrete with 'in your face' 5W's, it opens the door to the accessibility of writing," she said. "Then, top it off with the curiosity of well-thought-out questions, active listening to responses, mix in the urgency of a deadline ... you have the recipe for success."

It's a win-win situation as students view their work with pride and help keep journalism alive. They understand the value and importance of supporting their local newspapers, which helps others to also understand that more needs to be done. It can begin as soon as students enter the school system as a strong foundation to promote the passion they have for journalism and spread it within their communities from kindergarten through college and beyond.

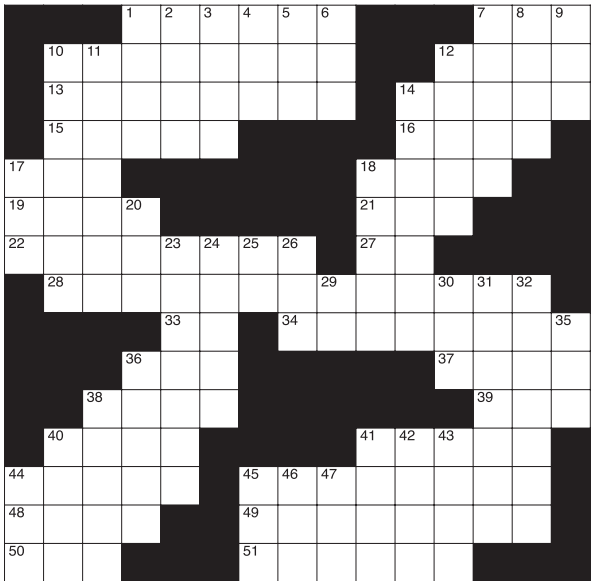

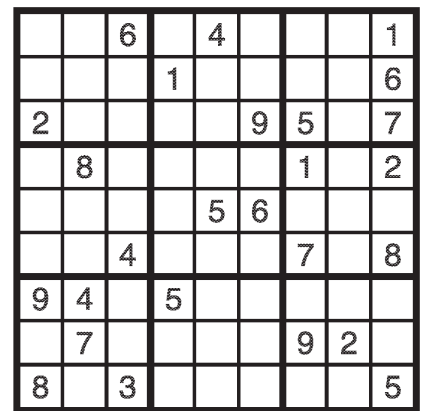

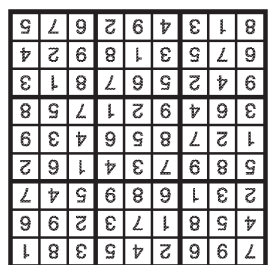
