Man Fatally Stabbed, No Suspect in Sight

A man is dead following a stabbing in the rear of Mucho Loco Deli on Tuesday, December 17th.

Officers from the 73rd Precinct responded to 441 Sutter Avenue, near Junius Street, around 6:40 a.m. where they found Najee Berry, 34, of Crown Heights, suffering from multiple stab wounds to the torso and back.

Paramedics rushed the victim to Brookdale Hospital where he was pronounced deceased.

Circumstances leading up to the stabbing are unclear as of press time. Detectives were seen going through store surveillance for more details on the suspect.

No arrests have been made, and an investigation is ongoing.

Fire Kills One and Critically Injures Another

An early morning fire at 516 Vermont Street, off of Dumont Avenue, left a man dead and another critically wounded on Tuesday, December 17th.

Firefighters arrived at the location around 1:20 a.m. and quickly found the men through heavy smoke and surrounded by fire while searching the first floor of the mixed-use building. They began pre-lifesaving CPR before taking them to Brookdale Hospital.

About 60 firefighters from 12 units used three hose lines to knock down the main body of fire. A neighbor who said he was in disbelief, told the *Canarsie Courier*, "The smoke was so bad it started drifting into my house. I thought my place was on fire."

Searches of the upper floor were negative.

As of Tuesday morning, members of the FDNY Fire Marshal's office were sifting through the debris and searching the building to determine the origin and cause of the fire. They removed a propane tank and motorcycle from the building.

Holiday Greetings Among Uncertainty for Marine Park Community

Local residents gathered on Tuesday, December 17th, for a Holiday Party sponsored by the Marine Park Community Association (MPCA) in alliance with the Madison-Marine-Homecrest Civic Association (MMHCA) for food, well-wishes and an update on serious issues facing the community. The event took place at the Carmine Carro Community Center, at 3000 Fillmore Avenue.

A large turnout of residents were in attendance, and many were very vocal about the recent passage of the City of Yes for Housing Opportunity proposal that passed in the City Council by a vote of 31-20 on December 5th, despite “no” votes from Councilwomen Farah Louis and Mercedes Narcisse, as well as opposition from several community boards.

The rezoning plan, which could lead to more high-rise building developments across the five boroughs, includes building more homes above stores, allowing homeowners to build apartments on single-family lots and changing parking mandates. It has sparked serious concerns among residents who fear these changes will have significant effects on the quality of life in Marine Park and surrounding areas.

“Parking is already an issue, and high-rise projects could lead to an overflow of residents, possibly empty storefronts, reduced parking and affect our schools which already suffer from overcrowding if more kids are in classrooms,” said Lucy Brincat, a local resident.

Brincat, who is a member of a boat club in Sheepshead Bay, also spoke about how development has altered the landscape of that area and not for the better.

“I don’t even recognize Sheepshead Bay anymore. It was a beautiful fishing community but now it’s full of high-rises. A lot of the old diners and fishing supply stores are gone, and the increase in bike lanes have taken away parking, and motorbikes and electric bikes speed down the bike lanes creating hazards for drivers.”

Her fears were echoed by MPCA President Robert Mazzuchin, who has also been a fierce opponent of the City of Yes. “We don’t want high-rises to alter the area and possibly the park as well,” he said.

Residents also asked about the changes that the NYC Sanitation Department is imposing regarding garbage pickup. Starting this past November, all residential buildings (consisting of one to nine units) must place garbage in plastic bins with secure lids that are 55 gallons or less outside their homes.

After a warning period, residents who don’t follow the rules will have to pay an initial \$50 fine being enforced by the city starting on January 2, 2025, followed by a \$100 fine for the second offense and \$200 fines for any additional offenses.

“Sanitation doesn’t respond to e-mails, but we will continue to try and get someone from Sanitation to speak to us in the spring, Mazzuchin said.

In addition, board members also spoke about being wary of potential scams during the holiday season, particularly with gift cards coming by mail. Residents were warned to avoid using any mailboxes that feel sticky when placing mail inside them.

The next meeting of the MMHCA and MPCA will be held on January 21, 2025, at the Carmine Carro Community Center.

Stargazers See Shooting Stars at Seba Park

With a clear night sky, stargazers gathered on Friday night, December 13th, at Seba Park, located on Gerritsen and Seba Avenues, to view the Geminids meteor shower and other celestial objects.

The Marine Park Alliance organized the event in coordination with Assistant Scoutmaster Paul Jones, Scout Troop 396, who provided the telescope and binoculars to see the night sky. People also used an app called Star Tracker Lite to identify the objects they were looking at.

This meteor shower, the Geminids, is observed during mid-December each year. At its peak, more than 100 meteors can be seen per hour under perfect conditions. However, the Geminids are a unique meteor shower as they come from an asteroid, 3200 Phaethon, as opposed to other meteor showers, which come from comets.

"It was great to show people the universe," said Jones. "I'm very happy that we had a great crowd and a lot of kids and people saw the planets for the first time with their own eyes, and it was incredible to see."

With the Celestine motorized telescope, the stargazers saw our planetary neighbors. Attendees saw Venus right before it set, Jupiter and four of its moons, the rings of Saturn and, at the very end, Mars, rising above the horizon.

"This is kinda like a once-in-a-lifetime thing; how often are you going to be able to

see so many shooting stars? I could make all my wishes tonight," said Demetra Philippou of Mill Basin. Her daughter agreed with mild excitement.

The cold weather didn't keep a group from gathering in awe to view the meteor shower with their very own eyes.

"You'd think, 'Oh, it's too cold,' but no, people enjoyed it," said Margot Perron, MPA board member. "If they dress well and are ready for it, families will bring their kids; it's an outing for them. Personally, I think the park is a special place at night and the more programs that we can do like this, the better. People experiencing the park at night is uncommon, but it was amazing and fun."

The last Festival of Lights event—"Winter Solstice"—will be held from 5 to 7 p.m. on Saturday, December 21st, at the field behind Seba Playground, at Gerritsen and Seba Avenues. The Winter Solstice is the shortest day of the year and with more telescopes on hand, residents are invited once more to see the stars.

Celebrating Kwanzaa with Dancing, Joy and Unity

Residents of Marine Park gathered at the Carmine Carro Community Center on Saturday afternoon, December 14th, to observe a pre-celebration of the upcoming holiday, Kwanzaa.

Organized by the Marine Park Alliance, with the support of other organizations and Brooklyn College's assistant professor, Dr. Simanique Moody, who taught attendees the origins and meaning of Kwanzaa.

Beginning on December 26th and ending on January 1st, Kwanzaa celebrates aspects of African-American and African cultures and promotes the values of community, hope and unity, the latter of which was a significant part of the event.

The ceremony began with a musical program performed by Arleen Griffith, Brother Mac and Baba Raheem. The three played shakers, yangban and djembe (African drums).

Councilwoman Mercedes Narcisse of District 46 was in attendance and announced her support for the MPA, the Kwanzaa celebration, and the community overall, and stressed the importance of unity during these times.

"The more you understand each other, you see how close you are. The more you spend time and understand what the person stands for, the easier it gets to work together," she said. "So, I am so grateful to be part of such an amazing club."

Moody did a libation custom as she poured water into a plant and repeated the name of an elder who had passed, as the attendees called out their names. She then explained the history of Kwanzaa and its significance today.

Maulana Karenga, an African-American activist, created the holiday in 1966, basing it on Pan-African values as well as African-American culture and how

everyone in the community, regardless of race, can follow those values.

Afterward, Griffith conducted a dance workshop after the African dance, funga, a dance of hospitality, followed by everyone singing the hymn, "Lift Every Voice and Sing."

"The people are welcoming and very friendly, and it's a wonderful, festive atmosphere. We appreciate having had the opportunity to serve the community," said Griffith. "I think the dancing made it even more lively. The music invigorates and no one can resist the drums, so we all dance enjoyment together."

Near the end of the ceremony, Moody invited volunteers from the audience to light the candles in the kinara, which in Swahili means "candle holder." The lighting begins with the black candle in the center and then moves from left to right. The color of the candles all represent something—black represents the African people, red represents the struggle of the African people and green represents future hope.

As there are seven candles in the kinara, there are the Nguzo Saba (seven principles) to Kwanzaa, which are — Umoja (unity), Kujichagulia (self-determination), Ujamaa (collective work), Ujamaa (cooperative economics), Nia (purpose), Kuumba (creativity) and Imani — (faith).

As the event concluded, there was one more dance in which everyone in the center participated and expressed the principle of unity and joy.

"I was thrilled by the outpouring of community support, particularly seeing people of all ages and cultural backgrounds come together to learn about the history of Kwanzaa," said Moody. "The drumming provided by the Healing Drums Community ensemble truly created an atmosphere of Umoja, which is the first of the Nguzo Saba of Kwanzaa. I felt great pride and joy at seeing how enthusiastically the audience members participated in tonight's pre-Kwanzaa celebration, from dancing and singing to reciting the Nguzo Saba during the candlelighting ceremony."

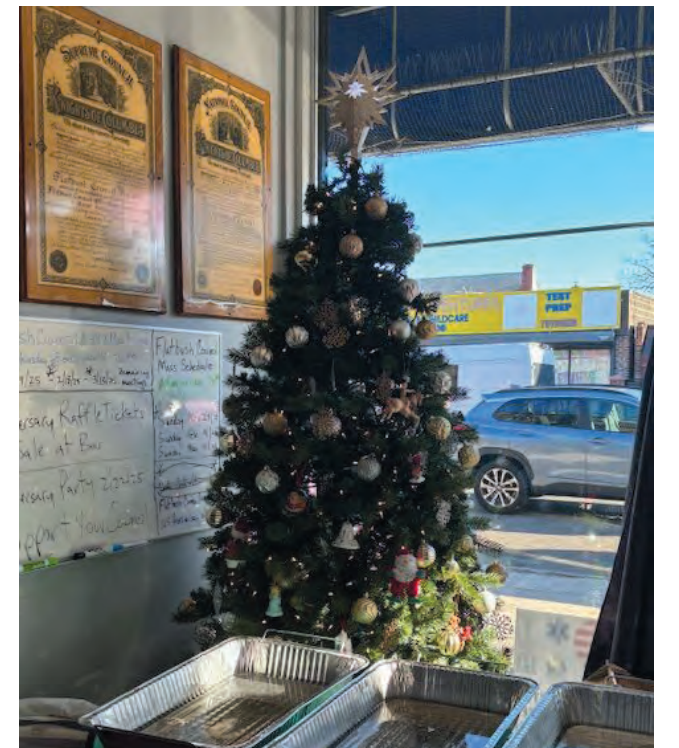

With Hanukkah just around the corner, members of the Jewish community, in the neighborhoods of Marine Park and Bergen Beach, have been busy decorating their homes for the eight-night Festival of Lights -- a celebration of freedom from oppression and religious expression that commemorates the rededication of the Second Temple of Jerusalem as well as the sacred miracle of the oil.

It is fitting then that giant inflatable menorahs, teddy bears with dreidels, and even a Hanukkah Express train, have made their grand debuts on lawns and in driveways. Seeing Hanukkah decorations displayed with pride has been especially meaningful for some members of the Jewish community, who say they represent triumph against adversity and mark the end of what has been a difficult year, marred by vile cases of bigotry and rising antisemitism.

Fun fact: There is more than one way to spell "Hanukkah" because the Hebrew word *הַחֲנוּכָה* does not have a direct English translation. There is no single, standard way to transliterate the sounds in the Hebrew word using the letters of the Latin alphabet. The most common spellings are Hanukkah and Chanukah, but some say they have seen the word spelled more than 20 different ways!

Diners Can't Get Enough of Flatlands Buffet

Anyone looking for a great spot to dine locally need look no further than Flatlands Buffet, located at 5614 Flatlands Avenue. The eatery, which opened on November 1st, serves a wide array of Asian and American cuisine aimed at satisfying even the most finicky palate.

The restaurant offers a seafood menu that includes assorted sushi rolls, pepper shrimp, spicy salmon, fried squid rings, snow crab legs and hibachi. It also serves fried chicken, mac and cheese, creamy spinach topped with cheese, as well as pizza, soups, salads and plenty of desserts.

According to Allen Li, who assists his older brother and proprietor, Michael Li, with the day-to-day operations of the restaurant, Flatlands Buffet offers over 200 items daily. On any given day, Monday through Friday, particularly around lunchtime, which is from 11 a.m. to 3:30 p.m., a steady stream of patrons stops by to either eat in or take out.

However, the younger Li told the *Canarsie Courier* that the restaurant is always swarming on Saturdays and Sundays as that's when the church crowd comes in. He explained that they have rooms to accommodate such large groups and even for those celebrating a special occasion like a birthday or graduation.

The prices for the lunch buffet are \$12.99 for adults, \$6.49 for children, ages 6 to 11, and \$4.49 for children, 3 to 5 years old. Dinner follows from 3:30 to 10:30 p.m. for a slightly higher price. Adults pay \$17.99, children, ages 6 to 11, \$9.99, while the charge for those 3 to 5 years old is \$6.99.

The restaurant also offers All Day Buffet on Saturday, Sunday and holidays. The price for an adult meal is \$18.99, \$10.99 for children, 6 to 11, and for those 3 to 5 years old, \$7.99. There's also a takeout menu with items priced from \$5.99 to \$8.99 per pound.

Seniors, 65 years old and over, get 10% off their meals. On Sundays only, any adult gets to pay \$1.00 for one child's meal.

The *Canarsie Courier* spoke with several patrons including Judy and Heather, who were there for the third time. They all said the same thing, "The food is really good, and the price is cheaper than anywhere else. That's why we keep coming back."

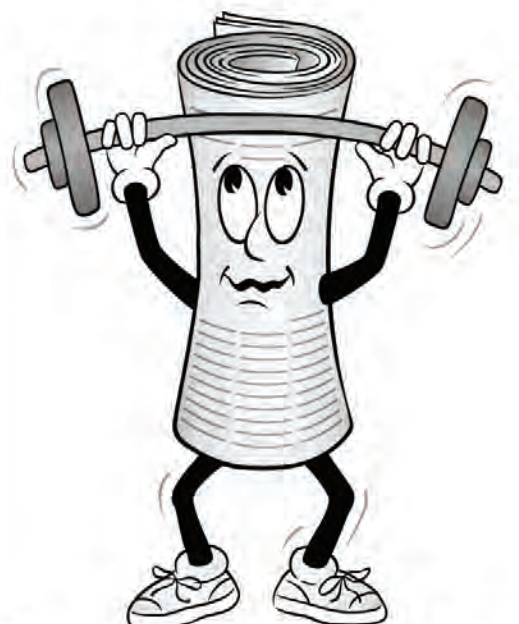
