Sheepshead Bay Man Fatally Shot at Nostrand Houses, Suspect Charged

An arrest was made in the homicide of a 31-yearold man who was shot inside of a NYCHA apartment around 2:30 a.m. on Saturday, April 5th.

On April 6th, police arrested Javon Japa, 25, and charged him with murder and criminal possession of a weapon.

Police from the 61st Precinct/PSA1 responded to 3012 Avenue W, off Batchelder Street, in the Nostrand Houses, where they observed the victim, Vincent Idlett, with multiple gunshot wounds to his body, according to police.

EMS took the victim to Maimonides Hospital in critical condition where he was later pronounced dead, police said.

East Flatbush Armed Suspect Shot by NYPD Officer

A police officer shot a convicted felon who slashed a male in the arm at 21 Duryea Place on Friday, March 28th, after he charged at officers following a multiblock chase.

Uniformed police officers from the 70th Precinct responded to the scene around 11:40 p.m. where they saw the victim and the alleged perpetrator. Upon confronting the suspect, he fled the location on foot, and a chase by the officers ensued, according to NYPD Chief of Department John Chell, who spoke at a press conference later that evening.

After chasing the suspect, for 2.5 blocks, to East 21st Street, between Beverley Road and Regent Place, the suspect stopped, turned around and made "intentional movements" as though he was carrying a firearm, according to Chell. At that time, the perpetrator charged at the officers. One of the officers fired his weapon multiple times, hitting the suspect twice. "Our officer had to defend himself," Chell said.

A knife and an additional cutting instrument were recovered at the crime scene.







The suspect, 29, was taken to an area hospital. Chell said he has four prior arrests (three for assault and one for a gun). He also slashed two people with a scissor in Manhattan this past January.

The slashing victim was also taken to an area hospital and is expected to be okay.

The suspect then fled on foot southbound on Williams Avenue.



Despite the gloomy weather, a hearty bunch of diehard nature lovers gathered on Sunday afternoon, April 6th, to relish in the spectacular beauty of Marine Park's cherry blossom grove (located at East 36th Street and Avenue U), in peak bloom – a very special treat that lasts only about one week, each year.

In their native country of Japan, cherry blossom trees are celebrated during Sakura festivals, and it is traditional for people to practice hanami (flower gazing), as they equate the delicate and short-lived beauty of the tree's blossoms to the very nature of life itself. In fact, it was only in 1921 that Japan first shared these trees with the United States, presenting some 3,000 saplings as a gift of friendship, to be planted in Washington, D.C. where they continue to grace the Nation's capital today.

Much closer to home, Marine Park Alliance Executive Director Scott Middleton welcomed the group to explore Marine Park's very own grove, which, for many years, was composed entirely of several Yoshino cherry blossom trees, originally planted in the 1980s. They can be easily identified by their contorted trunks and iconic pale pink flowers. Only recently were a number of young Okame cherry blossom trees introduced, punctuating the landscape with their far more saturated deep-pink hues and straight trunks, as well as one example of the later-blooming Kwanzan variety.

NYC's Director of Street Tree Planting, secondgeneration arborist and self-described tree nerd, Navé Strauss, led the group on an in-depth, educational journey through the grove, discussing everything from lichens on the tree's bark, to their dark red, tannin-rich ornamental berries and the way each tree is selected for a particular area.

He explained how important it is to leave adequate space between a mulch ring and the tree trunk, how young trees need around 20 gallons of water a week to thrive and even passed around the delicate flowers of an Okame for closer examination. The group was mesmerized by the complex intricacies of the blooms and said they were blown away by Strauss' tremendous wealth of knowledge on the subject.

To end the approximate two-hour event, a local resident, Yoko Miyamoto Sheridan, invited the group to form a circle under the canopy of the cherry blossom trees, hold hands and envision themselves rooted to the earth, as they made a collective sound - a tradition she explained would help to welcome the spring season.

hternation


lying, which was printed in the *Courier*. I still read the *Courier* and submitted articles on

By Angela G. Nannetti With the Aviator Sports Complex, located in Floyd Bennett Field, set to close when the current lease expires on April 14th and approval of a new operator still pending with the National Park Service (NPS), parents are making a last, valiant effort to save youth sports.

Since news of a potential closure first broke (see "Families Rally to Save Aviator Sports Complex," Canarsie Courier, March 27, 2025), families have come together in a great show of unity, organizing rallies, circulating petitions and enlisting the support of their local elected officials. With the deadline looming, however, the Aviator Sports Community (ASC) decided to extend their reach even further, drafting a powerful letter and a heartwarming collection of testimonials from young athletes they have dubbed the "Dream Package," which parents have hand-delivered to elected officials all over the city and as far off as Washington, D.C.

"The community is calling on you to stand with us in this fight to keep dreams alive," wrote the ASC, in their letter. "Aviator is a place where futures are shaped, and without it, the aspirations of so many young athletes will be cut short before they have the chance to flourish. We urge you to visit our center, meet our athletes and witness firsthand the transformative

Their kids' statement, according to the ASC, "illustrate the deep impact the facility has had on their lives and how tragic its closure would be. Their voices deserve to be heard, and their dreams deserve to continue soaring."

From hopeful 11-year-old hockey player, Ben, who looks forward to a time when other kids can enjoy the Aviator without threat of closure as he has for the past nine years, to 10-year ice skating veteran, Sasha, who dreams of qualifying for the National Figure Skating Competitions and six-year veteran gymnast, Grace, who dreams of making it to the Olympics, each and every child is putting in the work required to make their "Aviator Dreams" come true.

While families are prepared to continue their fight to the very end if necessary, the NPS is running out of precious time and must act posthaste if they intend to prevent the disruption and possible permanent closure of the Aviator Sports Complex.

Coyle Street Shelter Fight Intensifies Amid Protests and Political Alliances By Robert Pearl

The battle over a proposed homeless shelter at 2134 Coyle Street is escalating, as community resistance shows no signs of slowing, and political alliances cross traditional party lines. Councilwoman Mercedes Narcisse finds herself in the eye of the storm, facing growing pressure from residents and intense scrutiny from her own constituents, despite her public opposition to the shelter plan (see "Community Rallies Against Homeless Shelter 'Bait and Switch,'" Canarsie Courier, April 3, 2025).

On Tuesday, April 1st, dozens of protestors marched on Narcisse's District Office at 5827 Flatlands Avenue, holding signs, chanting slogans and demanding answers. Demonstrators have been camping out at the

Coyle Street site around the clock in an effort to block construction and prevent developers from breaking ground. Many remain unconvinced by Narcisse's insistence that she is on their side.

"The City Council member has the authority to overturn this, but she's playing games!" one protestor shouted. "She promised to 'solve the problem' in one week — we're waiting to see how this turns out!"

Narcisse made a rain-soaked visit to the Coyle Street site on Saturday, April 5th, where she showed solidarity with those opposing the shelter and expressed frustration with how the city administration handled the process. "I share the anger and frustration expressed by many at the recent protest," she said. "The way this shelter plan was handled by the city administration was unacceptable." Narcisse claimed she had been misled by developers who initially presented the project as affordable housing and that her office was slowwalked by the Department of Social Services (DSS) when trying to get clarity.

"From the moment my office was notified, I pushed back," she added. "I've been clear that the community was misled, and I've been fighting ever since to reverse this decision and return to the original plan for affordable housing — the one that was approved by Community Board 15 and the City Council."

Despite these assurances, residents remain skeptical. Critics say Narcisse was informed far earlier than she let on, citing a letter circulated by DSS that was allegedly sent to her in July 2023. That letter, they claim, provided advance notice of the shelter, making her later claims of surprise hard to believe. In response, Narcisse insists that she was also a victim of misinformation and continues to push back through official channels.

Also at the center of controversy is CB15 Chairperson Theresa Scavo, who was called out by residents who allege that she too had advance knowledge that the promised housing would be converted into a homeless shelter, citing that she received a similar letter directly addressed to her. Without denying it, Scavo said she passed it along to elected officials who said they would take care of it. "I want to assure everyone that I remain in direct communication with the mayoral administration and am actively participating in a working group with city officials to seek a resolution that truly reflects the will and best interests of our community," Narcisse said, vowing to keep residents informed.

Narcisse told protestors on Saturday, "I have a plan," though she has yet to publicly release specifics. That plan is believed to involve navigating new programs under the city's Affordable Housing Services initiative, which offers rental guarantees to nonprofit developers and aims to convert shelters into permanent housing solutions. While officials describe the program as innovative, residents argue it bypasses local input and imposes policy on communities under the guise of progress.

In an unexpected twist, Narcisse found a vocal ally in Councilwoman Inna Vernikov, a Republican representing neighboring District 48. At a South Brooklyn Republican Club meeting on Wednesday, April 2nd, Vernikov offered a strong and personal defense of her Democratic colleague. "I know this may surprise you, but I stand with Councilwoman Narcisse on this issue," she said. "I believe her when she says she was lied to. I've been lied to too. I have no reason to doubt her sincerity."

Vernikov explained that although the shelter is not located within her district, it affects many of her constituents, including businesses and a nearby daycare center. "The bigger fight is against the city administration and these agencies who continuously mislead communities," she said. "We must come together on this."

She emphasized the need for community unity and urged protestors not to lose focus: "You have a right to be angry, and you have a right to demand the truth." Vernikov said she is working with Narcisse on this issue and has also signed onto a joint letter to Mayor Eric Adams opposing the shelter. She criticized the DSS and Department of Homeless Services for ignoring local voices.

The demonstrators, however, remain unconvinced by words alone. "Our community will continue to hold her accountable for her poor decisions," a protestor stated. "The resolution is simple — STOP the homeless shelter!"

Protest organizers are calling on neighbors to stay engaged and informed and to vote in upcoming elections. "Stay connected with what's happening in your community — if not, you will be left out of the conversation!" one speaker urged.

As tents remain planted and signs remain high at the Coyle Street site, residents continue their roundthe-clock resistance. With Narcisse's self-imposed timeline to present her plan in the coming weeks to "solve the problem" ticking away, the neighborhood is waiting — and watching. For now, the work and the protests continue.

Community Issues Discussed at Joint Southern Brooklyn Civic Meeting

Following a rally at 2134 Coyle Street over a planned homeless shelter near the border of Sheepshead Bay and Marine Park, a large crowd gathered at the Carmine Carro Community Center, located at 3000 Fillmore Avenue, on Tuesday, March 18th.

The fired-up group was there for the monthly joint meeting of the Marine Park Community Association and the Madison-Marine-Homecrest Civic Association, and they were eager to discuss their concerns for the community.

While the Coyle Street shelter and the controversial Flatbush Avenue lithium-ion battery storage facilities were, of course, hot topics at the meeting, other issues were also discussed.

"There's a lot going on out in Community Board 18, from Canarsie all the way to Marine Park and right in between," Community Board 18 District Manager Sue Ann Partnow said.

Mailbox fishing is a big problem in the area, as Partnow explained. Mail fishing is when a thief tampers

with a mailbox in order to steal checks or envelopes of cash out of the mail. It's often done by sticking glue or sticky traps in the opening of postal drop-off boxes to catch the envelopes placed inside.

Partnow announced to cheers from the crowd that an arrest was made for mailbox fishing on Utica and Flatlands Avenues. Police picked up five men with 40 checks on them.

The NYPD recommends dropping your mail off directly at the post office and using a gel pen when filling out checks, as gel ink is harder to remove from paper than ballpoint pen ink. Brooklyn District Attorney's Office representative Alexander Gurevich also spoke about this issue, recommending people use direct deposit to send and receive payments, rather than snail-mail.

"Speaking with my partners in the FBI, they consider any case of a check in the mail is automatically compromised," Gurevich said. "If it's in the mail, it's compromised."

Partnow also touched on a new National Grid pipeline inspection project happening this month from Bay Ridge all the way to Avenue U and Hendrickson Street in Marine Park. The project will last around six weeks and will bring construction chaos to the route, though transit officials will be on-site to assist traffic flow. Concerns were also raised about two other proposed buildings that would benefit developers but aren't clearly a win for the community.

One is a proposed condo building to be built on an empty lot in Mill Basin at East 66th Street and Dakota Place. The small space is proposed to get a 90-unit building, without a parking lot for its residents. The other is a seven-story building at Flatlands Avenue and East 55th Street that would have commercial space on the ground floor and residential space on the above floors.

"We have a few developers that want to put up things that we don't want," Partnow said.

On a positive note, young dancers from the O'Malley Irish Dance Academy, at 3051 Nostrand Avenue, performed multiple numbers, to the elation of the crowd.

The next meeting of the combined civics will take place on Tuesday, April 15th, at 7 p.m. at the Carmine Carro Community Center.

The Genuine Gems Inc. hosted its second annual Women's History Month celebration on Saturday, March 22nd, at the Canarsie Educational Campus, 1600 Rockaway Parkway. A roomful of young women and girls of all ages and from various backgrounds were recognized and honored for their achievements during the event, which was themed "Girl Power."

The celebration featured music, games and panel discussions which were led by some of the young women. They explored topics that addressed issues such as self-worth, accountability, confidence and overcoming adversity, while sharing some of their personal stories with the aim of inspiring others.

One person spoke about the despair she experienced while in the hospital and rehab, after a shooting incident three years ago that left her paralyzed. Perched in her wheelchair, she disclosed, "I was lost -- confused. I didn't know what my life would look like after me being able-bodied or walking for 22 years of my life."

The now-budding entrepreneur hoped that by sharing her story, "people who are in the same situation, or who aren't in the same situation, would know that there is life on the other side after an injury like mine." She challenged other young women to take a page out of her book and rise above any impediments they might encounter.

Another young entrepreneur, 14-year-old Love Lee, had an engaging conversation with the audience about confidence – one of the tenets of The Genuine Gems – and spoke about what it meant to her personally. "To me, confidence is having the self-assurance that I know what I'm doing and that I'm capable of doing whatever I put my mind to," she said. She backed up her statement by reciting a Bible verse she was taught by her parents when she was much younger: "I can do all things through Christ who strengthens me."

The Black Girl Magic singer also entertained the audience with some of her lyrics: "Don't you ever let no one take away the power you possess. Be confident wherever you go and let your Black Girl beauty shine through." She ended by having them repeat, "I am confident. I am amazing. I am beautiful. And I know who I am."

The Genuine Gems Inc. was founded by Jenai Williams, who was inspired to start the organization after becoming the guardian of three young girls. At the time, their mom was unable to take care of them and Williams, who couldn't bear the thought of seeing them separated, took them in.

She told the *Canarsie Courier* that after having the siblings in her care for a year, she decided to start a program that would empower young girls "to educate young girls on how to be young ladies; how to have etiquette; how to break the stigma of what beauty is supposed to be," among other things.

Williams mentors girls ages 6 through 17 and currently has 27 of them in the program. She often receives help from many of the "graduates" who return to assist her and board members, Rhundele Rodney and Shayla McKinnon, with mentoring the younger ones.


