Canarsie Deserves More Than Condolences — It Deserves Investment

Another life lost. On Friday, June 6th, just before 2 a.m., a 42-year-old man was fatally shot at the corner of Rockaway Parkway and Avenue N. It was the fifth shooting in the 69th Precinct this year — and the first homicide. As police canvass the scene and neighbors mourn another senseless act of violence, one truth becomes clearer than ever: our city cannot continue to afford to look away.

This tragedy, like too many before it, underscores a grim reality — Canarsie lacks the foundational infrastructure that every community deserves to thrive. While nearby neighborhoods like Brownsville and East Flatbush have received transformative public investments — \$160 million for the Brownsville Recreation Center, \$141 million for the Shirley Chisholm Center — Canarsie has been left behind.

We are not asking for more than our neighbors. We are asking for equity. We are asking for lifesaving, life-affirming infrastructure in the form of a state-of-

the-art community center.

Such a center would not merely be a building; it would be a sanctuary. A place for after-school programming, civic engagement, swimming lessons, environmental justice initiatives, advocacy training and mental health support. It would be a hub for safety and healing — a place where young people can dream beyond the confines of survival.

Thanks to Councilwoman Mercedes Narcisse and other community leaders, Canarsie secured \$1.6 million for violence prevention last year. That was a critical down payment. But it's not nearly enough. We need bold, long-term investments — investments that reflect our humanity and affirm that our lives matter.

Mayor Adams, NYC Parks Commissioner Rodriguez-Rosa, Brooklyn Parks Commissioner Maher: Canarsie is calling. We are ready to partner. We are ready to plan. We are ready to build. What we are not ready to do is bury another neighbor while



waiting for overdue justice.

The time to invest in Canarsie is now. *Jibreel Jalloh is an award-winning organizer with experience working at the highest levels of government. He is the Founder and Executive Director of The Flossy Organization, a nonprofit dedicated to closing the advocacy gap through education and activism. Over the past few years, they have worked to end gun violence, increase transit options and secure investments in local green spaces. Man Fatally Shot, Detectives Looking for Suspect

A man was killed during an early morning shooting at Rockaway Parkway and Avenue N on Friday, June 6th.

Officers from the 69th Precinct found the 42-year-old male victim suffering from a single gunshot wound to the back around 1:50 a.m.

EMS took the victim, who was conscious and alert, to Brookdale Hospital, but he succumbed to his injuries, police said.

Crime Scene Unit members collected three pieces of evidence at the scene.

There are no arrests, and an investigation is ongoing.

Car Jumps Tracks Evading Police at East 105 Street Station

A car, evading a traffic stop, crashed onto the tracks at the East 105 Street station of the "L" train, shutting down service for hours, on Monday, June 2nd.

Officers from the 75th Precinct attempted to pull over Feruv Telmanov, 23, of Midwood, at Cozine Avenue and Malta Street. Telmanov was operating a Jeep without a license and tinted windows. The driver fled the scene at a high rate of speed and eventually struck a fence and landed on the tracks of the Manhattan bound side of the "L" train at East 105 Street around 10:30 p.m., according to NYPD.

A witness told the *Canarsie Courier*, "I saw cops running on the tracks; I had no clue what was happening." No injuries were reported.

Telmanov was taken into custody and charged with reckless endangerment, criminal possession of a firearm and equipment failure. An investigation is ongoing.

MTA officials had power restored to the train station by 4 a.m.

Partial Roof Collapse Kills Construction Worker

A construction worker died after he was trapped in a partial roof collapse of a two-story building in Marine Park on Thursday, June 5th.

Engine Company 309 and Tower Ladder 159 were first to reach the worker who was trapped under a refrigeration unit and a slab of concrete at Quentin Road and East 33rd Street, before 9 a.m.

Workers were doing repairs and installing a walk-in freezer in a steakhouse on the first floor of the building when the 43-year-old got trapped under the fallen concrete slab.

"They used special airbags to lift the slab

of concrete," according to FDNY's Assistant Deputy Chief Joe Duggan.

Rescue Company 2 and Squad Company 252 then used their shoring equipment to make the area safe. Rescue paramedics helped gain access to the badly hurt member.

EMS took the victim to Brookdale Hospital in critical condition, but he later succumbed to his injuries.

The Department of Buildings and National Grid are investigating the incident. No work permits had been filed with the DOB. The building was vacated and sealed while an investigation continues.

A wealth of curiosity, collaboration and creativity could be seen at every table of the District 22 Science Expo, as students proudly shared their hard work with visitors on Tuesday, May 20th.

The gym at P.S. 236 Mill Basin, located at 6302 Avenue U, was jam-packed with exuberant students from schools throughout the district, so excited to share the results of their experiments that they looked about ready to burst.

Two 3rd-grade students, Justin Xu and Yosiah Santana, from P.S. 194 Raoul Wallenberg, located at 3117 Avenue W, shared their project, titled “Can Water go Against Gravity,” displaying the cups of colored water and paper towels that they used to test their hypothesis.

Right beside them were two students who had studied whether water could break rock. They were ready and willing to discuss their findings and show off the actual rocks they had worked with.

Four students from P.S. 236 investigated “Better Homes to Prevent Flooding” and had detailed models to illustrate their conclusions. Another nearby group discussed the invasive spotted lanternfly population.

The subjects of the students' projects were timely, practical and informed by the rich science curriculum that has become the bedrock of the district’s STEM initiative, setting the bar for schools higher than ever.

Science and Medicine Middle School Hosts Vibrant Career Day in Canarsie

The hallways of the Science and Medicine Middle School 366, at 965 East 107th Street, buzzed with inspiration and curiosity on Thursday, May 22nd, as students participated in a dynamic Career Day event.

Organized by music teacher Allison Megherian and the school's guidance counselor, the event brought professionals from across New York City into the classrooms, offering students a real-world glimpse into a wide range of careers.

"This is our third year doing this," said Megherian, who has been teaching for 13 years and is the founding music teacher at the STEM-focused middle school. "Every year, we reach out to people in advance, but this time we even had folks walking in off the street to volunteer, especially since the bad weather made some of our original speakers cancel. It was amazing how it all came together."

Despite the stormy skies, Career Day was a success, thanks in part to the resilience and commitment of the school's staff and the enthusiasm of the visiting professionals. Guests included architects, doctors, nurses, librarians, local entrepreneurs and representatives

from Grace Alternative, a program already embedded within the school's support system.

"One of the students told me how inspired they were by a woman who spoke about data and research," Megherian said. "It's encouraging to know that as a science and medicine school, our students are truly connecting with those career paths."

The theme for the event encouraged students to "Dress for success. Strive for excellence. Follow your dreams. Find your future."

The vibrant flyer featuring community icons — from firefighters to pilots — reflected the school's inclusive approach to career exploration. The school also leveraged a digital QR sign-in for participants, reflecting a modern and organized approach to event management.

Megherian, who transitioned from Brownsville to Canarsie to help launch the school's music program eight years ago, said her passion for education has only grown stronger over time. She recently delivered a TED Talk on helping teachers reclaim their love for the classroom through mindfulness and music, principles she brings into her daily instruction.

Her motivation to co-create Career Day stemmed



from a moment of transition within the school.

"One of our school counselors had left, and I didn't want the event to disappear," she said. "I told the other counselor, 'If you want to do it, I'll do it with you.' It's such an important part of middle school, especially as students begin thinking about high school and beyond."

As the students left Career Day with new ambitions, fresh insights and perhaps a few career dreams planted, one thing was certain: the future is bright in Canarsie.

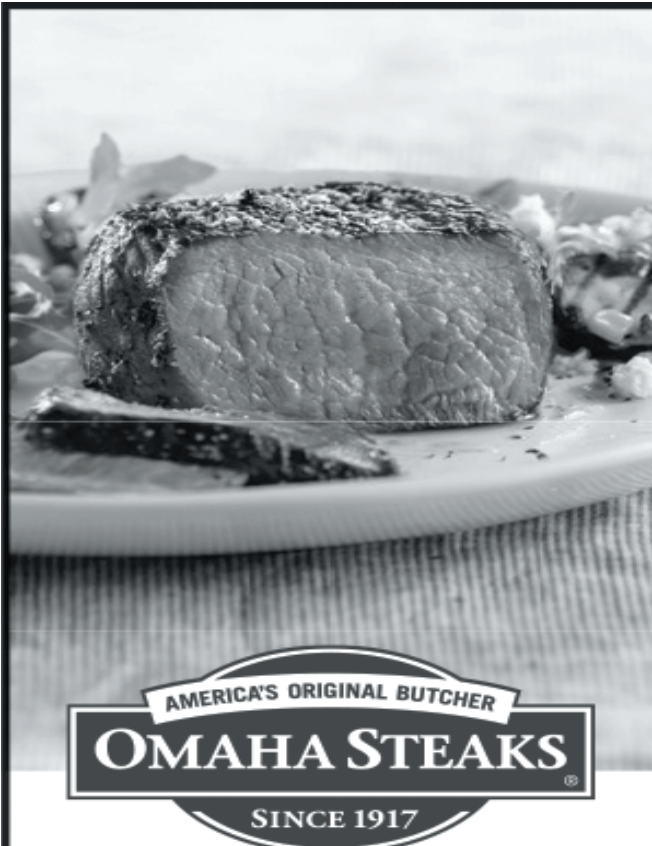

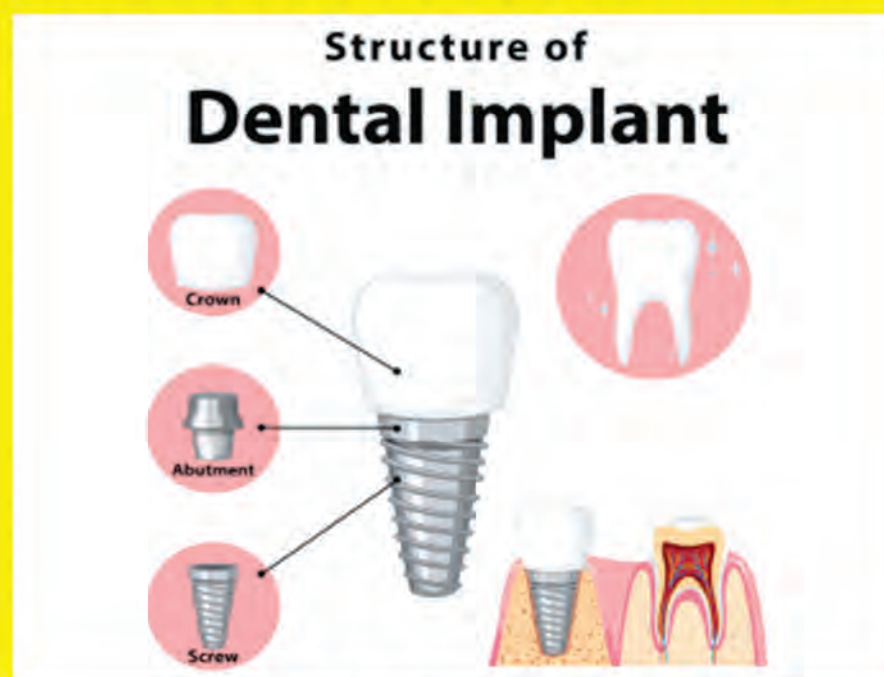

District Attorney Celebrates Older Adults at the Hebrew Educational Society

More than 100 older adults attended the Older Americans Month celebration hosted by Brooklyn District Attorney Eric Gonzalez, Community Board 18 District Manager Sue Ann Partnow and the Jewish Association Serving the Aging, better known as JASA, on Tuesday, May 20th, at the Hebrew Educational Society (H.E.S.), located at 9502 Seaview Avenue.

Gonzalez and his team, which included Chief of Investigations Patricia McNeill, Investigation and Fraud Specialist Frank Ungerer and Elder Abuse Coordinator Talia Orband, shared information about various scams and offered resources to combat elder abuse and increase community safety.

Many of the scams discussed were per-

petrated online — with dubious pop-ups, emails and links inviting would-be victims to click on them — or by phone calls where, for example, a supposed representative from a “reputable” bank would call regarding a problem with their account. In order to rectify the problem, the victim is told they must provide their personal banking information.

“These scams are more and more aggressive and more and more convincing,” Gonzalez stated.

He also spoke about other scams that involved Medicare and health insurance, E-ZPass or toll payment, sweepstakes, lotteries and online dating, where people are asked constantly to wire money for one reason or another.

“If you’ve never done a wire transfer

in your life, don't start now," the DA cautioned.

That advice was underscored by Ungerer, who was adamant about not answering calls from unknown numbers or opening texts and emails from unfamiliar sources.

"The best thing you can do when you receive those calls, emails or texts is to ignore them," he stressed.

Ungerer also reported on a series of other scams, including deed theft, and referred homeowners to the Automated City Register Information System website, where they can sign up for notifications regarding any activity on their property. He said that anyone who's been scammed should call the DA's Action Center at 718-250-2340 to report it, echoing more advice given by Gonzalez who urged, "Don't be afraid or ashamed."

Orband spoke about different types of elder abuse, which she stated could be physical, emotional, neglect or financial, and gave some insight into some of the signs or red flags that might be indicative of abuse.

They include unexplained bruises, self-isolation or the person being withdrawn.

She explained that, unfortunately, that type of abuse is sometimes committed by family members and the victims in those cases are almost always unwilling to report it.

P.S. 207 Student Performance of *The Jungle Book* Charms Audience

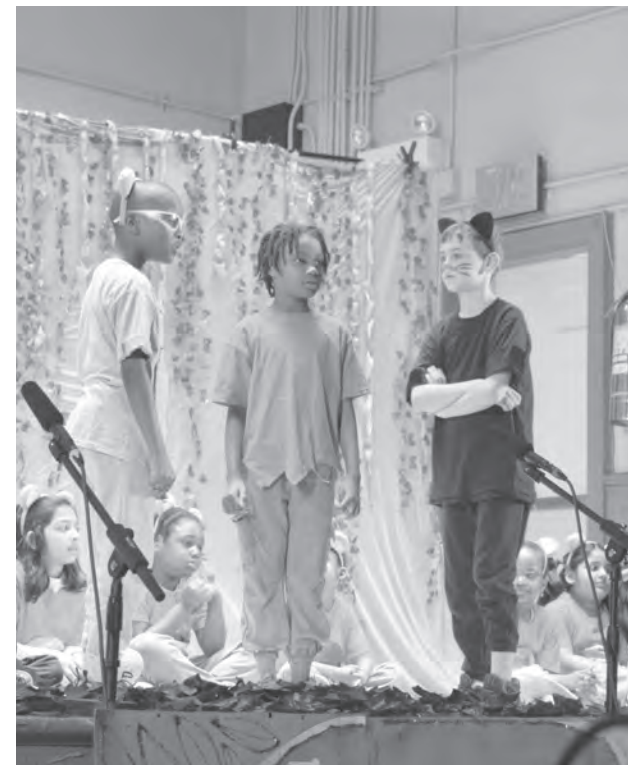

Spotlighting Canarsie Fallen Hero Charlie Fusco for Memorial Day (March 5, 1980 - April 1, 2022)

Growing up on East 93rd Street between Foster Avenue and Farragut Road in the 1980s, Charles P. Fusco, better known as "Charlie" or "Chuck," was the quintessential Canarsie kid.

He loved cartoons and sports — football, basketball, hockey, soccer, baseball — and fishing. As a teen, you could find him hanging out at A&L Candy Store on East 92nd Street and Farragut Road after school or playing football in the street.

As the years went by, life took him in many different directions, and Fusco achieved great success as an electrician, before eventually finding his rightful place with the United States Army as a Combat Engineer with the 82nd Airborne Division. He was stationed at Fort Bragg, North Carolina and rose to the rank of SPC/E04.

Members of the 82nd Airborne Division, also known as the "All American Division," have long been recognized for their tremendous courage and ability, specializing in operations they call "jumps," where paratroopers literally jump out of a plane, specifically C-130 and C-17 aircraft, and parachute down to a target area, a key deployment tactic frequently used in a variety of military applications.

During his service, Fusco completed a total of 25 jumps, many in training, others in combat and one very memorable jump, which was witnessed by his family during a visit to the base.

In May 2011, during the Iraq War, officially known as Operation Iraqi Freedom, Fusco was deployed, serving an eight-month tour. While on a mission to locate Improvised Explosive Devices, the High Mobility Multipurpose Wheeled Vehicle, or Humvee, that his unit was traveling in hit one such device. It was powerful enough to blow up their vehicle, which took all the damage, sparing the lives of all the soldiers it carried. The explosion did, however, permanently impair Fusco's hearing.

Highly decorated, Fusco was the recipient of a number of honors, including the Army Commendation Meritorious Unit Medal, Army Superior Unit Award, Army Good Conduct Medal, National Defense Service Medal, Global War on Terrorism Service Medal, Iraq Campaign Service Medal, Campaign Star, Army Service Ribbon, Combat Action Badge and Parachutist Award.

When asked what his son loved most about being in the Army, Fusco's father, Rocco Fusco, said it was "the comradery, being part of a unit and going out on missions," but that what his son loved most in life was his daughter, who was truly the apple of his eye from the very moment she was born, his greatest pride and joy.

Members of Fusco's family say that his heart was his calling card. Kind to a fault and a protector at the core, Fusco could always tell who needed some support or encouragement and was always ready to offer it. Though his life was cut tragically short, his legacy will live on through his daughter and the indelible mark he has left on the hearts of all who knew and loved him.

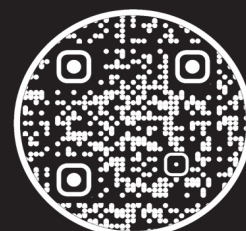

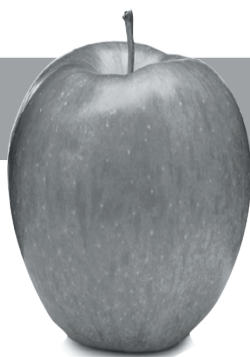
