## Man Struck by Brick During Verbal Dispute

The NYPD is asking for the public's assistance in identifying an individual wanted in connection with an assault on a 67-year-old man in Canarsie.

The incident occurred around 12:05 a.m. on Tuesday, December 30th, in the vicinity of East 94th Street and Avenue J.

## Detectives Searching for Clues in Church Avenue Stabbing

Police from the 67th Precinct responded to a stabbing at 3113 Church Avenue on Monday, January 5th, around 11:25 p.m.

A 31-year-old man was stabbed multiple times in the torso, police said. EMS took the victim to Kings County Hospital where he was listed in stable condition.

There are no arrests, and an investigation is ongoing.



## Leaders Fighting Hate Honored by The Bridge MCP at Annual Unity in Action Holiday Celebration

It was standing room only at the “Annual Unity in Action Holiday Celebration and Award Ceremony,” on Sunday, December 21st, in honor of four extraordinary individuals who were recognized by The Bridge Multicultural and Advocacy Project (The Bridge MCP) for their remarkable achievements and unwavering dedication to not only the communities they serve, but also society as a whole.

The ceremony, held at 1894 Flatbush Avenue, included a lavish dinner and was emceed by Annesa Ali, director of Special Projects at The Bridge MCP. It commenced with prayers by Bishop Ebony Kirkland from Church of the Living God, Honorable Judge Menachem “Mendy” Mirocznik and Hassan Bakiriddin who represented the Jewish and Muslim faiths, respectively. In her opening remarks, Ali stated, “Unity is very personal to me. It’s not just a word but how I live my life. Tonight, we’re not just ending the year; we’re celebrating connection, compassion and the people who showed up for us when we needed them the most, and that’s what The Bridge is all about.”

Mark Appel, founder of The Bridge MCP, welcomed the honorees and over 300 guests who braved the cold to be there. “Today is a strong message of celebration,” he told attendees. Appel expressed thanks to the Lord for keeping everyone throughout 2025 and prayed for the same in the coming year. “In a world which is so different, divided by differences, ethnicities, gender and other facets, at The Bridge MCP we see people as people. One people. One God,” he added. Before introducing the honorees, Appel also gave a report of the Foundation’s numerous achievements during the past year, which included the expansion of *Bridge TV* network.

Honorable Vijah Ramjattan, executive director of NYC Mayor’s Office for the Prevention of Hate Crimes, was recognized for his advocacy on antisemitism. “When I walked in the room this afternoon, what I saw was New York City in its glory. I saw every race, every faith, every culture. So, when people tell me that unity is not possible in New York City -- just look at this room,” he told the gathering, glancing from side to side. The former counselor at Rikers Island jail spoke about a press conference his office held in Crown Heights recently, “to denounce the stabbing of a Jewish man who was stabbed just because he was Jewish.”

Ramjattan reiterated his mantra -- “Hate has no place in New York City” -- and referenced the musings of one of the rabbis at the press conference. “What does light look like during Hannukah? Where does the light come from?” the rabbi wanted to know. He found the answer to his question by looking at those who surrounded him. Seeing people of different colors, different communities, different faiths, the rabbi admitted, “Hate has no place in New York City” and acknowledged, “That is the light in Hannukah.”

Dr. Alix Desulme, mayor of North Miami, Florida, was also recognized for repudiating hate and bigotry and had

received numerous accolades for his efforts -- notably for holding an “Israel Solidarity Rally” in the aftermath of the October 7, 2023, Hamas attack on Israel. Recently, at the “North American Mayors Summit Against Antisemitism,” the Haitian-born Desulme was awarded the Combat Antisemitism Movement’s (CAM) Mayors of Courage Award, an honor conferred on leaders who confront hatred and support Jewish communities.

Honorable Assemblywoman Rodneyse Bichotte-Hermelyn, another honoree, praised Appel for his vision in creating a safe space “where we could all come together to fellowship and to fight.” The Brooklyn Democratic Party Leader, who has made significant accomplishments in healthcare, education, housing, economic development, criminal justice and election reform, stated, “We are here because we have a purpose” and reminded all that “no matter what race, nationality, origin, religion, color of your skin, gender, orientation, whatever or whoever you are, however you identify yourself, we are one. One people.”

A community advocate and civil rights litigator, Honorable Benjamin Pinczewski who often provided pro bono service to many in his community, was also acknowledged. A staunch supporter of human rights for marginalized persons in particular, Pinczewski shared the story of how he once stepped up to defend a young couple who was being harassed and disrespected by the waiter at a restaurant, because he believed they were gay. “I don’t tolerate anything like that. I have to speak up!” Pinczewski told the gathering. Unbeknownst to him at the time, the “altercation” was all an act and part of *WABC*’s TV show, *What Would You Do?*

During the ceremony, there was the traditional lighting of a menorah which was performed by community leader Dr. Sima Karetzaya, Lana GL and Desulme. There were also brief remarks by Councilwoman Farah Louis and

Mercedes Narcisse, Brooklyn District Attorney Eric Gonzalez, Debbie Louis from the Office of Governor Kathy Hochul, NYPD Deputy Chief Richie Taylor, and Alex and Bessie Kuravsky, parents of 11-month-old Binyomin Zachariah Kuravsky who was tragically killed by a malfunctioning steam radiator in their apartment.

The Kuravskys mentioned the anguish they experienced in losing their baby and in such a horrific manner and that they are now striving to turn their pain into purpose. They expressed their gratitude to Councilwoman Louis for her support and for pushing to get the Ben-Z Law, which the dad referred to as “a call for child safety,” passed. Ben-Z law mandates (among other things) biennial inspections of steam radiators in apartments housing children under the age of 6 and in building common areas.

The couple was comforted by Bichotte-Hermelyn who had also suffered the tragic loss of a baby through someone else’s negligence. Like the Kuravskys, she was propelled by pain to do something to prevent that tragedy from happening to others. Bichotte-Hermelyn’s efforts resulted in the passage of the Jonah Bichotte Cowan Law, which establishes parameters for treatment when an expectant mother presents at a hospital with concerns about being in preterm labor. As Appel put it, the grieving mother was able to turn her tragedy into a blessing for others.

While embracing the Kuravskys, the assemblymember applauded Appel, stating, “Mark brings all of us together when we are happy and when we are sad, when we are celebrating and when we are mourning.”

“The essential message that should resonate in our communities must be one of unity, regardless of our political or religious beliefs,” Appel asserted.

The ceremony also featured uplifting music which included Bob Marley’s “One Love” and culminated with a lively hora that several guests joined.

**Flatlands****New Year's Day is Soup Joumou Day in Haitian History, Culture and Remembrance**

Community members gathered at 5827 Flatlands Avenue on New Year's Day, January 1, 2026, to celebrate a cherished Haitian tradition by sharing Soup Joumou, also known as Haitian pumpkin soup, a hearty and savory squash-based soup that symbolizes Haiti's independence and freedom.

Councilwoman Mercedes Narcisse first hosted the free soup giveaway in 2021 and has made it an annual tradition at her office as a delicious way to share Haitian culture and history with the broader community on what is also Haitian Independence Day.

"It marks Haiti's independence and freedom, resilience and hope for the year ahead," she said in her announcement flyer. "For generations, families have gathered on January 1st to share this meal and to reflect on where we have been and where we are going."

Narcisse introduced WNYX TV board member Jean Victor who gave opening remarks on the history and significance of the soup.

Soup Joumou commemorates Haiti's liberation from French colonial rule and slavery. Haiti declared its independence on January 1, 1804, after the world's first successful slave revolt the year before, becoming the first Black republic.

During slavery, enslaved Africans were forced to prepare the soup for their French masters in Haiti but were not allowed to eat it themselves. After independence, the soup was symbolic of victory, liberty and self-determination.

The tradition of making the soup into a national ritual is credited to Marie-Claire Heureuse Dessalines, the wife of Jean-Jacques Dessalines, leader of the 1803 rebellion and first ruler of Haiti after independence.

"It was the women's leadership that said this is how we

will move forward," Narcisse said. "She [Dessalines] said it was important and imperative, moving forward, when we declare our independence, to drink that soup and to enjoy it, our freedom and our liberation."

Several folding tables were set up to accommodate a steady stream of constituents, community members, friends, family and supporters who were served in shifts from 11 a.m. to 1 p.m.

The soup was prepared by Dr. Michael Charles, and support for the event was provided by Transformation Life Ministries Pastor Windsor Nelson, who offered a blessing prior to the meal.

Charles said that his recipe was typical among Haitian households. The key ingredient is the round, yellow squash, distinct from the common pumpkins in the United States, which was pureed and used as the base for the pots of soup

served that day. The meat version used plenty of beef and cut-up leg bones. There was also a vegetarian version available with plenty of bread on the side.

The cooked and pureed squash added the sweetness, golden color and thickness to the soup that was combined with the beef, stock, leafy greens, starchy and assorted vegetables, penne pasta, green onions, garlic, hot peppers and spices to give it a touch of heat.

Charles told the *Canarsie Courier* that January 2nd, Jour des Aïeux (Ancestor's Day), is another significant date in Haitian culture when Haitian families would gather for a family dinner to honor their ancestors.

Among those attending the event were The Bridge Multicultural and Advocacy Project Executive Director Mark Appel; newly elected Supreme Court Judge, Hon. Brian Gotlieb; Police Officer Jonathan Meo from the 114th Outreach Division in Queens; and constituent Betty Chalmers with daughter, Tascha Chalmers, who is Philadelphia's commissioner on aging.

Appel shared with the *Canarsie Courier* the historical connection between Haiti and Israel's independence, noting Haiti's vote in favor of the United Nations partition plan in 1947 that helped pave the way to Israel's independence the following year.

"Haiti and my community, the Jewish community, have a very close relationship," Appel said. "Haiti was the one that participated in the final vote on Israel in the United Nations in 1948, and also, they have a very close relationship."

Attendees talked about their connection to the Haitian community among themselves and expressed their appreciation and support for Narcisse, whose district has a large Haitian-American constituency. They left with a new understanding about the significance of New Year's Day within that community.





## East New York Man Celebrates Fifth Year of Giving Toys to Children for the Holidays

It was a bitter, cold day on December 20th, but 794 New Lots Avenue was abuzz with warmth, laughter and wrapped gifts for the community as longtime organizer Malik Sherrod continued his tradition of giving back.

Now in its fifth year in East New York, the annual toy distribution has been growing, offering hundreds of toys for area children – all without using any funding from government grants. “This is friends, family, businesses. There are no grants in here. There is no government money in here. It’s people who care,” Sherrod said.

This year’s campaign managed to raise around 480 pieces, with organizers set to hit over 600. “We didn’t meet our target at the beginning,” Sherrod said. “But a friend has just cashed out his money, so we are going to meet our target.”

The giveaway has almost doubled over the years, having begun with over 200 toys. The program originated in Orangeburg, South Carolina when the program’s founder attended South Carolina State University. He brought the program to New York when he moved back.

“My spirit just said, ‘Continue this and do it here,’” Sherrod explained. “And here we are.”

The donations are from former classmates, friends and family, as well as local businesses such as Almark Pharmacy that supports the giveaway event every year in the form of finances, as well as goods. “Half of that table, they bought that too,” one organizer said, gesturing to mounds of gift-wrapped presents from Almark.

The gifts were also wrapped by four separate groups of volunteers, another indication that the initiative was well-supported. This year’s event was also supported by the generosity of members of Emmanuel Baptist Church, located at 279 Lafayette Avenue.

Jerry Alexis, a current servant leader of the church’s Men’s Ministry, said “When Malik told me about this event, I had to be there. It’s about giving back to the community and keeping the community together, especially our young people.”

“We will not wait for anyone to help us,” Emile Vi- aud, another leader from the Men’s Ministry, stated. “We can help ourselves, and that’s what we always have done. This will continue to happen every year.”

This year’s participation occurred only a few weeks after Sherrod had hip surgery on November 24th. However, he says he never seriously thought about not hosting this event. “I’m exhausted, but I thank and praise God that we’re out here giving toys to the children of East New York.”

For those responsible for organizing, there is more at stake than just toys. “Every year, I just had to provide something,” Sherrod said. “Something they could put on their wall. Something they’ll remember.”

As families lined up, now holding brightly colored gifts in their arms, it was clear: community care isn’t just for a season in East New York.

In a library transformed by holiday cheer, the message was clear: through community, compassion and shared effort, moments of happiness and hope can still shine brightly — even in the most difficult of times.

"We're here at the solstice, the last event of the year -- the shortest day of the year -- and even in harsh conditions, cold, dark, windy, there are still things that we can learn from nature."

The MPA will host Mulchfest '26 at the Marine Park Avenue U Parking Lot from 9:30 to 11:30 a.m. on Saturday, January 10th, where volunteers will distribute mulch, remove holiday decorations and prep trees for the woodchipper. On Sunday, January 18th, there will be a Blood Drive at the Carro Community Center, 3000 Fillmore Avenue, from 10 a.m. to 2 p.m.




